Show the AUTHOR’ s name on any issued copy of the COMPOSITION;

Make the AUTHOR proofread the COMPOSITION before marketing it;

Carry out high quality PDF versions of the unpublished original compositions, of the arrangements or transcriptions of public property pieces supplied by the AUTHOR;

Launch and promote the COMPOSITION through the internet.

In particular “ Quiver” General Partnership agrees not to require or claim any copyright of the hereinbefore COMPOSITION;
